<p><b>RETIRED MEMBER:</b> a person who is a member of the Association and who has been retired by reason of: (1) Reaching retirement age; (2) Who has retired prematurely for medical reasons; (3) Has retired due to downsizing, amalgamation of the municipality, or reorganisation; and (4) Is not receiving any form of remuneration from a municipality, except as a result of an election to a municipal council.</p>	\$30.00	\$3.90	\$33.90
<p><b>CORPORATE MEMBERSHIP</b> Shall consist of a maximum of 12 employees and shall be limited to a municipality or school board or other realty taxing authority. Each Corporate membership must be accompanied with a list of individuals to be included in the membership at the time of payment of dues. A named individual shall be a full or part time employee of a municipal corporation or school board in the Province of Ontario who is involved in the administration/collection of property taxes, assessment or municipal revenues. Membership lists remain in place for one year subject to change only in the case of change in employment status for any of the individuals.
